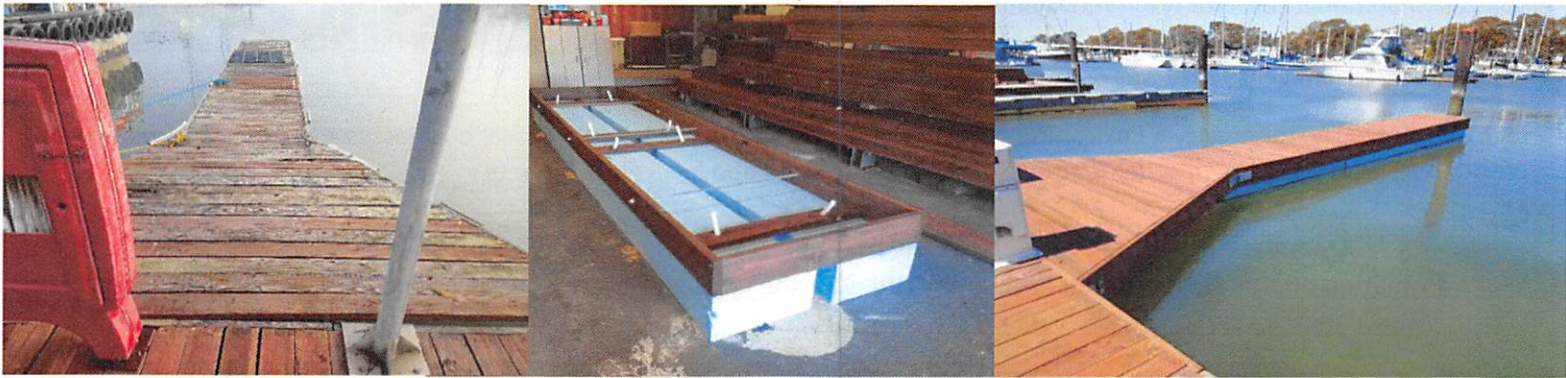

Thinking About Selling Your Boat?

- Slip Rental Agreements are non-transferable. When selling your boat, make sure the new owner has made arrangements for the boat to be removed from the marina or has completed the application process and executed a Slip Rental Agreement prior to the sale being final.
- Upon termination of a Slip Rental Agreement, unless a new agreement with the new owner has been executed, sold boats must be removed immediately.
- We ask and encourage you to write a courtesy letter or email to the marina office notifying us of your intent to sell your boat.

Key Fob Policies

Each key fob issued shall be assigned a key ID number by the Marina and a specific user as identified by Renter.

Renter shall not loan or reassign key(s) without express written permission from the Marina. Renter shall immediately notify Marina in writing should assigned user(s) change.

Renter shall immediately notify Marina in the event key fob(s) become lost or stolen. Failure to comply with these terms shall be cause for termination of Agreement.

What if I Abandon My Boat?

Under California law any owner found guilty of abandoning a vessel shall be fined \$1,000 to \$3000, and may be ordered to pay any additional costs for the removal and disposal of the vessel to the removing agency. Abandoning a boat is one of the worst things a boat owner can do to get rid of an unwanted boat. When a boat is abandoned the detrimental effects can be immediate, and may have serious consequences to:

Public safety • Water quality • Environment and sensitive habitats • Navigation • Local businesses • Marinas and waterway residences • Structures and other features • Resources of state and local governments

Proper vessel disposal is a vital part of clean and responsible boating, and if it's your boat it's your responsibility.

Wood Hull Surveys

Is your vessel seaworthy?

The Vallejo Marina has implemented a new practice that will require all Wood Hulled Vessels to have an out of water hull survey conducted every four years. This survey must be performed by a certified marine surveyor.

The Marina Staff will be contacting all Marina Berthers who have wood hulled vessels by February 1, 2019. Berthers must submit proof of a survey within 90 days after being contacted by Marina Staff.

The Marina staff will except out of water hull surveys completed in the past year by a certified marine surveyor.

Park Vallejo Update

- C, E, F, J, K Dock Lots & the Harbor Way Lot, are designated as free, three-hour time-limited parking lots.
- Dock Lot, located in front of the Vallejo Municipal Marina at 42 Harbor Way, will become a daily/monthly paid lot. Overnight parking in the I Dock lot will require a parking permit.
- Lot M, located at 3 Curtola Parkway, has been re-designated as a Marina/Boat Launch Parking Lot. Lot M is open to the public 5:30 a.m. to 8:00 p.m. as a daily/monthly paid lot. No overnight parking will be permitted within Lot M.
- Marina Parking Permits will be available for \$20/month or \$5/day, per vehicle. Marina Berthers may purchase discounted permits for \$10/month.
- As of February 10, 2020, vehicles parked in Marina Parking Lots will be subject to enforcement for not following posted parking policies. This includes parking longer than 3-hours in designated time-limited lots, or parking without a valid monthly or daily permit.
