**For City Boards and Commissions**, except for the Commission on Culture & the Arts, Human Relations, McCune Commissions, and the Participatory Budgeting Steering Committee, all appointed members must complete and file a Statement of Economic Interests, Form 700, within 30 days of appointment. **All City Board and Commission members** must complete AB 1234 Ethics training and file a Certificate of Completion within 30 days of appointment.

In most instances, to be eligible for appointment, applicants must be residents of the City of

Vallejo. Information regarding the duties of each board and commission and specific criteria for appointment may be found within each application. With some exceptions, appointments are typically for a term of 4 years.

**Applications will remain open until a sufficient number have been received in the City Clerk's Office.**

Interviews with the City Council will be held in January/February 2023. Specific dates will be announced at a later date. Applicants must attend the interview to be considered for appointment on a committee or commission
