**VALLEJO, CA** – The City of Vallejo is requesting applications to serve on a number of the City's boards and commissions. Vallejo residents who are interested in serving on an advisory body are invited to submit an application and supplemental questionnaire for consideration.

**For City Boards and Commissions**, except for the Commission on Culture & the Arts, Human Relations, McCune Collection, Marina Advisory, and the Participatory Budgeting Steering Committee, all appointed members must complete and file a Statement of Economic Interests, Form 700, within 30 days of appointment. **All City Board and Commission members** must complete AB 1234 Ethics training and file a Certificate of Completion within 30 days of appointment.

In most instances, to be eligible for appointment, applicants must be residents of the City of Vallejo. Information regarding the duties of each board and commission and specific criteria for appointment may be found within each application. With some exceptions, appointments are typically for a term of 4 years.

**The application period will close  
Friday, January 20, 2023, at 5:00 pm**

Interviews with the City Council will be held in February 2023. Specific dates will be announced at a later date. Applicants must attend the interview to be considered for appointment on a committee or commission.
