Make your voice heard and get involved with City government. Consider serving on a City advisory committee, board and/or commission. Vallejo residents who are interested in serving are invited to submit an application and supplemental questionnaire for consideration.

\*Applicants for the Vallejo Housing Authority Board of Commissioners must be a participant in HUD's Housing Choice Voucher Program at the time of application and one of the two tenant members must be at least 62 years of age or older. In accordance with Health & Safety Code Section 34272(a), tenant commissioners shall be appointed for a term of two years.

With the exception of the City-Schools Taskforce members, all appointed members must complete and file a Statement of Economic Interests, Form 700 within 30 days of appointment. All members must complete AB 1234 Ethics training and file a Certificate of Completion within 30 days of appointment.

In most instances, to be eligible for appointment, applicants must be residents of the City of Vallejo. Information regarding the duties of each board and commission, and specific criteria for appointment may be found within each application. With some exceptions, appointments are typically for a term of four years.

**Applications must be received no later than close of business on Monday, November 30.**

City Council interviews and appointments have tentatively been set for Tuesday, December 15 at 6:00 p.m. in City Council Chambers. Applicants are invited to attend and interact with the City Council.
