PUBLIC NOTICE
REVISED NEIGHBORHOOD STABILIZATION PROGRAM (NSP) AREAS OF
GREATEST NEED

In March, 2009, the City of Vallejo received a supplemental allocation of \$2.6 million in Federal Community Development Block Grant (CDBG) Program funds through the U. S. Department of Housing and Urban Development's (HUD) Neighborhood Stabilization Program (NSP). NSP funds are to be used to acquire, rehabilitate, and resell foreclosed and abandoned properties in the areas of greatest need in Vallejo, in order to help stabilize neighborhoods and arrest blight.

The City submitted its NSP application to HUD in November, 2008. Based on the data available to the City at that time, the North Vallejo and Central Vallejo areas, which also include the Country Club Crest and Central City CDBG Target Area neighborhoods, respectively, had among the highest rates of foreclosures and subprime mortgage loans in Vallejo, and were likely to see high rates of home foreclosures for the foreseeable future. Since that time, the number of foreclosures in Vallejo, and the geographic areas impacted, has increased, in Zip Codes 94589 (North Vallejo), 94590 (Central Vallejo), and 94591 (East Vallejo). In order to address these conditions, effective February 2, 2010, the City and its partners will utilize NSP funds as available for the acquisition, redevelopment, and resale of abandoned and foreclosed residential properties anywhere in the aforementioned Zip Codes, but with a continuing priority to expend NSP funds in the Country Club Crest (Priority 1), and Central City (Priority 2).
